acting through the ministry of Financial Services, Economic Development and Digital Transformation (MFSEDDT) is seeking the services of a competent Catering Service to provide meal services at the temporary Detention Centre located at Hotel Castle Maria for a period of one (1) year (hereinafter referred to as the "Service").

#### SCOPE OF WORKS

The proposed service is to ensure compliance in ensuring all meals are prepared and delivered within the time stipulated for meals of persons held in the detention center by the Immigration Department for a period of one (1) year.

#### INSTRUCTIONS TO TENDERERS

Tenderers are required to furnish the following:

- A completed Form of Tender. This form must be completed without alteration to its wording or format, and no substitutes shall be accepted except for the one provided;
- ii. Tenderers will be required to provide proof that the company or individual is in good standing with respect to taxes, duties, social security and national health insurance contributions, company registration, or payments due to the Government of the Virgin Islands. Certificates of Good Standing must be obtained from the Director of Social Security Board and National Health Insurance, and the Commissioner of Inland Revenue:
- iii. Tenderers operating in the British Virgin Islands are required to submit a Trade License (valid for 2025) specific for the type of work detailed in the tender document (If Partnership of Sole Proprietorship).
- Tenderers registered as companies in the British Virgin Islands are required to submit

compilance with all the requirements set out in the Instruction to Tenderers.

Failure on the part of tenderers to enclose the supporting documentation indicated above with each respective tender will render the tender non-responsive on the date of the opening of tenders.
