VI Government Seeks Professionals for the Landscaping and Manicuring of the Park Adjacent to the QEII Park

FOR THE LANDSCAPING AND MANICURING OF PARK ADJACENT TO THE QUEEN ELIZABETH II PARK

OBJECTIVE

The park adjacent to the Queen Elizabeth II Park requires regular maintenance to preserve its beauty, safety, and functionality as a key public space. Without proper care, overgrown vegetation, damaged pathways, and deteriorating amenities can reduce its appeal, create safety hazards, and negatively impact the environment. Maintaining the park ensures a clean, attractive, and welcoming space for recreation, cultural events, and tourism, while promoting community pride and environmental sustainability.

GENERAL PROVISIONS

The Government of the Virgin Islands (GOVI), acting through the Ministry of Environment, Natural Resources and Climate Change (MENR&CC), is accepting bids to award a contract for the Landscaping and Manicuring of the park adjacent to the Queen Elizabeth II Park. The contract will be for the duration of 2026 commencing on **1st March, 2026**.

SCOPE OF WORK

The proposed works consist of the following:

- a. Mow all grassy areas to a uniform height.
- b. Ensure even cutting without scalping or damaging the turf.

INSTRUCTIONS TO TENDERERS

Interested Tenderers are asked to furnish the following documents:

- i. Quotation of work
- ii. Certificates of Good Standing from Inland Revenue Department, Social Security Board, National Health Insurance, and Company Registry, if an incorporated company.
- iii. Valid Trade License for 2026 for cleaning/maintenance services
- iv. List of jobs of similar nature

Failure on the part of tenderers to enclose the supporting documentation indicated above will render the tender non-responsive on the date of **16th February, 2026**.

EVALUATION CRITERIA

- a. Price competitiveness 60%.
- b. Qualification, Experience and Reliability 20%.
- c. Response to proposal (completeness of all requested documents) 20%.

The proposed works consist of mowing all grassy areas to a uniform height. Ensuring even cutting without scalping or damaging the turf. Trimming the edges along pathways, flower beds, trees, and structures for a clean finish. Collect and dispose of grass clippings and any related debris after cutting. Addressing any areas requiring special attention among other duties.

Interested tenderers are asked to provide quotation of work, certificates of good standing from Inland Revenue Department, Social Security Board, National Health Insurance, and Company Registry. Other documents to include are, a valid trade license for 2026 for cleaning/maintenance services, and a list of jobs of similar nature.

Failure on the part of tenderers to enclose the supporting documentation indicated above will render the tender non-responsive on the date of 16 February, 2026.
