The Government of the Virgin Islands is seeking professional service from a qualified and reputable security company to Supply Security Services for the Transportation of Government Funds from various revenue collection sites on Tortola, Virgin Gorda, Anegeda, and Jost Van Dyke for a period of two (2) years.

The proposed services include the daily secure collection and transportation of public funds from designated government revenue collection points to the assigned banking institution.

The service provider is expected to implement and maintain robust security protocols and procedures to ensure the integrity of funds during transit and minimize the risk of loss, theft, or misappropriation.

Tenderers are required to furnish originals or notarised copies of the following certificates to be completed without alteration to its wording or format, technical proposal in accordance with Clause 2.1 financial proposal in accordance with Clause 2.2.

Tenderers will be required to provide proof that the company or individual is in good standing with respect to taxes, duties and social security and national health insurance contributions, company registration, or payments due to the Government of the Virgin Islands.

Failure on the part of tenderers to enclose the supporting documentation indicated with each respective tender will render the tender non-responsive on the date of the opening of tenders.

The Government of the Virgin Islands (GOVI) heretofore referred to as the "Tenderer", is seeking professional services from a qualified and reputable security company to **Supply Security Services for the Transportation of Government Funds** from various revenue collection sites on Tortola, Virgin Gorda, Anegada, and Jost Van Dyke for a period of two (2) years.

**SCOPE OF WORKS**

The proposed services include the daily secure collection and transportation of public funds from designated government revenue collection points to the assigned banking institution. The service provider is expected to implement and maintain robust security protocols and procedures to ensure the integrity of funds during transit and minimize the risk of loss, theft, or misappropriation.

**INSTRUCTIONS TO TENDERERS**

Tenderers are required to furnish original or notated copies of the following certificates:

- completed without alteration to its wording or format, and no substitution shall be accepted except for the one provided (Do Not Alter this Form).
- Technical Proposal in accordance with Clause 2.1.
- notated Proposal in accordance with Clause 2.2.
- Tenderers will be required to provide proof that the company or individual is in good standing with respect to taxes, debts and local security and national health insurance contributions, company registration, or payments due to the Government of the Virgin Islands. Certificates of Good Standing must be obtained from the Director of Social Security Board and National Health Insurance, and the

Commissioner of Island Revenue;

- Tenderers registered in compliance with the British Virgin Islands are required to submit a Certificate of Good Standing from the Commercial Registry and a Certificate of Incorporation;
- Tenderers operating in the British Virgin Islands are required to submit a Trade License valid for 2026, specific for the type of work detailed in the tender documents;
- Proof of possession of the equipment required for the job, by submission of copies of vehicle registration or insurance certificates. The required equipment must be in the British Virgin Islands at the time of the tender;
- Any other records required to be completed and submitted in accordance with the instructions to Tenderers. The Form of Tender and the Cost Proposal provided in these Tender Documents shall be used without exception.

**Notes:** The date of issue indicated on the above mentioned certificates should be no earlier than six months prior to the date of submission. Tenderers shall be deemed to meet compliance with all the requirements set out in the Instructions to Tenderers.
